THE COMMISSIONERS MET IN THE COUNCIL CONFERENCE ROOM OF THE CITY MUNICIPAL BUILDING, 301 S. BRANSON ST., MARION, INDIANA 46953 ON JANUARY 6, 1997 AT 8:30 AM.

IN ATTENDANCE WERE COMMISSIONERS RICHARD PUCKETT AND WALTER WOOD, COUNTY ATTORNEY GENE JOHNSON, COUNTY AUDITOR JUDY CARMICHAEL, COUNTY ENGINEER IRVING MILLER, HIGHWAY SUPERINTENDENT JOHN WEBSTER, AREA PLAN DIRECTOR CLAY GILLEY, COUNCILMAN PAUL BAKER, AND HENRY HOENIG OF THE CHRONICLE-TRIBUNE.

RICHARD PUCKETT CALLED THE MEETING TO ORDER AT 8:30 AM.
