

COMMISSIONERS MINUTES 4-7-97

THE COMMISSIONERS MET IN THE COUNCIL CONFERENCE ROOM OF THE CITY MUNICIPAL BUILDING, 301 S. BRANSON STREET, MARION, INDIANA 46953 ON APRIL 7, 1997 AT 8:30 A.M.

IN ATTENDANCE WERE COMMISSIONERS DAVID GLICKFIELD AND WALTER WOOD, COUNTY AUDITOR JUDY CARMICHAEL, HIGHWAY SUPERINTENDENT JOHN WEBSTER, AREA PLAN DIRECTOR CLAY GILLEY, COUNTY COUNCILMAN JOE ISAACS, SHERIFF DEPUTY MIKE BACK, RANDY MILLER, LARRY MANSHIP, RANDY McPIKE OF WBAT, AND HENRY HOENIG OF THE CHRONICLE-TRIBUNE.

DAVID GLICKFIELD CALLED THE MEETING TO ORDER AT 8:30 A.M.

WALTER WOOD MADE A MOTION TO APPROVE THE MINUTES OF THE LAST MEETING AND TO APPROVE THE CURRENT CLAIMS AND THE CURRENT PAYROLL. DAVID GLICKFIELD SECONDED THE MOTION AND THE MOTION CARRIED.

LARRY MANSHIP, OF MANSHIP SURVEYS, PRESENTED A PRIOR APPROVED PLAT FOR THE NEW FOX STATION ADDITION TO BE SIGNED. BOTH COMMISSIONERS, MR. WEBSTER AND MRS. CARMICHAEL SIGNED THE PLAT.

RANDY MILLER, OF MILLER & ASSOCIATES, SPOKE REQUESTING A VARIANCE FOR TREES AND A RECREATIONAL AREA, FOR THE CRANE POND SUBDIVISION. WALT WOOD MADE A MOTION TO APPROVE THE VARIANCE. DAVID GLICKFIELD SECONDED THE MOTION AND THE MOTION CARRIED.

JOHN WEBSTER, HIGHWAY SUPERINTENDENT, REPORTED THAT THE DEPARTMENT WAS BUSY PICKING UP TRASH, PLACING BERMSTONE, PATCHING AND INSTALLING GUARD RAILS. HE ALSO REPORTED THAT WORK HAD STARTED ON BRIDGE #86 IN BROOKHAVEN ADDITION.

COUNCILMAN JOE ISAACS GAVE THE MARCH 1997 DOG WARDEN REPORT. WALT WOOD MADE A MOTION TO ACCEPT THE REPORT. DAVID GLICKFIELD SECONDED THE MOTION AND THE MOTION CARRIED.

MIKE BACK, CAPTAIN OF THE GRANT COUNTY SHERIFF DEPARTMENT, REPORTED THAT DEMOLITION HAD STARTED AT THE COUNTY COMPLEX. HE STATED THE DEPARTMENT HAD PURCHASED OUTFITS, RESPIRATORS AND FILTERS TO ASSURE THE SAFETY OF THE INMATES DURING THIS PROJECT. CAPTAIN BACK ALSO REQUESTED A COPY OF ORDINANCE #3-1997 REGULATING TRAFFIC UPON THE PUBLIC ROADS OF GRANT COUNTY, READING "NO TRUCKS ALLOWED ON COUNTY ROAD 350E FROM 100S TO 200S IN CENTER TOWNSHIP".

WALTER WOOD MADE A MOTION TO APPROVE THE WALNUT CREEK REPORT FOR MARCH 1997. DAVID GLICKFIELD SECONDED THE MOTION AND THE MOTION CARRIED.
