## COMMISSIONERS MINUTES 4-28-97

THE COMMISSIONERS MET IN THE COUNCIL CONFERENCE ROOM OF THE CITY MUNICIPAL BUILDING, 301 S. BRANSON STREET, MARION, INDIANA 46953 ON APRIL 28, 1997 QT 8:30 A.M.

IN ATTENDANCE WERE COMMISSIONERS RICHARD PUCKETT AND WALTER WOOD, COUNTY AUDITOR JUDY CARMICHAEL, CAPTAIN MIKE BACK OF THE GRANT COUNTY SHERIFF DEPARTMENT, MAINTENANCE SUPERVISOR CHARLIE FISHER, LINDA WILK OF FAMILY SERVICES AND KARYN SHINSKI OF THE CHRONICLE-TRIBUNE.

RICHARD PUCKETT CALLED THE MEETING TO ORDER AT 8:30 A.M.

WALTER WOOD MADE A MOTION TO APPROVE THE MINUTES OF THE LAST MEETING AND TO APPROVE THE CURRENT CLAIMS AND THE CURRENT PAYROLL. DICK PUCKETT SECONDED THE MOTION AND THE MOTION CARRIED.

DAVID GLICKFIELD ENTERED THE MEETING.

CAPTAIN MIKE BACK OF THE SHERIFF DEPARTMENT DISCUSSED A PROBLEM WITH THE LIFT STATION LOCATED NEAR THE SHERIFF DEPARTMENT. HE PRESENTED A BID FROM SKYLINE ELECTRIC COMPANY FOR \$28,866 TO REPLACE THE ENTIRE SYSTEM, INCLUDING LINES, GUIDES, PUMPS, ELECTRONICS AND MOTORS - EVERYTHING EXCEPT THE CEMENT WELL. CHARLIE FISHER STATED HE HAD ONE MOTOR IN FOR REPAIR AT THIS TIME, AND THE BACK-UP HAS BEEN WIRED FOR SHORT TERM DURING THIS REPAIR. THE REPAIR WILL COST APPROXIMATELY \$1500. WALTER WOOD ASKED IF SINCE IT IS A TWO PUMP SYSTEM WOULD IT BE PROBABLE TO PURCHASE ONE NEW PUMP AND COMBINE THE GOOD PARTS OF THE PRESENT TWO FOR ONE GOOD PUMP. CHARLIE FISHER SAID HE WOULD CHECK INTO THAT POSSIBILITY. DICK PUCKETT SAID THERE HAD BEEN MANY REPAIRS ON THIS SYSTEM SINCE HE HAD BEEN IN OFFICE. IT WAS DECIDED TO LOOK INTO SEVERAL OPTIONS AND TO GET OTHER QUOTES ON A NEW SYSTEM.

CAPTAIN BACK AND LINDA WILK, FAMILY SERVICE DIRECTOR, EXPLAINED AN APPLICATION FOR A VICTIMS ASSISTANT GRANT FOR THE SHERIFF DEPARTMENT. LINDA EXPLAINED THAT SHE WOULD BE HIRING AND TRAINING THE NEW PERSON, IF THE GRANT IF AWARDED, AND THAT IT WOULD BE AT NO EXPENSE TO THE COUNTY GENERAL FUND. DICK PUCKETT AND JUDY CARMICHAEL SIGNED THE APPLICATION FOR THE GRANT.

CAPTAIN BACK ALSO MENTIONED THAT ON 700W SOUTH OF HIGHWAY 26 THE ROAD IS BEING TORE UP BY LARGE TRUCKS TRAVELING TO THE GRAIN ELEVATOR. THE SPEED LIMIT AND A STOP SIGN WAS DISCUSSED. CAPTAIN BACK STATED HE WOULD TALK WITH PEOPLE AT THE GRAIN ELEVATOR AND RESIDENTS OF THE AREA AND REPORT BACK TO THE COMMISSIONERS.

WALT WOOD MADE A MOTION TO SIGN THE GRIFFITH COST ALLOCATION CONTRACT. DAVID GLICKFIELD SECONDED THE MOTION AND THE MOTION CARRIED THREE AYES. DICK PUCKETT SIGNED THE CONTRACT.

WALT WOOD THANKED CHARLIE FISHER AND THE MAINTENANCE CREW FOR THE CLEAN-UP WORK AROUND THE COURT HOUSE.
