COMMISSIONERS MEETING JULY 9, 1997

THE COMMISSIONERS MET IN THE CITY COUNCIL CONFERENCE ROOM AT 9:00 A.M. ON JULY 9, 1997.

IN ATTENDANCE WERE COMMISSIONERS DICK PUCKETT AND WALT WOOD, COUNTY ATTORNEY GENE JOHNSON, AUDITOR JUDY CARMICHAEL, JIM SMITH OF RQAW, DAN MAYER OF TOTH-IRVIN, TIM DONAHUE OF TOTH-IRVIN, COUNCILMAN PAUL BAKER, RANDY McPIKE OF WBAT AND MARIA ROCCO OF WGOM.

DICK PUCKETT OPENED THE MEETING AT 9:00 A.M.

DAN MAYER READ THE SELECTED BIDS AS FOLLOWS;

JIM SMITH STATED THAT THE SHERIFF DEPARTMENT AND THE INMATES HAD DONE AN EXCELLENT JOB WITH THE DEMOLITION SAVING THE COUNTY APPROXIMATELY \$180,000.

DAN MAYER STATED THAT BY OPENING UP THE BUILDING AS THE INMATES HAD, IT ALSO LOWERED THE REST OF THE BIDS, SAVING EVEN MORE FOR THE COUNTY.

DOG WARDEN'S FREEZER

THE ELECTRICITY HAS BEEN RAN FOR THE FREEZER TO BE MOVED BEHIND A STORAGE BUILDING AT WALNUT CREEK MANOR. IT IS TO SIT ON A SLAB.

CHARLIE FISHER DISCUSSED HIS LEAVING ON JULY 25, FOR A POSITION AT MARION GENERAL HOSPITAL. HE STATED HE RECOMMENDED TERRY PARSON FOR HIS POSITION AND WOULD RECOMMEND THAT ROGER NEALIS BE MOVED TO DAY MAINTENANCE AND ANOTHER PERSON HIRED FOR SECOND SHIFT TO TAKE ROGER'S PLACE.

THE COMMISSIONERS ASKED FOR THE MAINTENANCE DEPARTMENT TO CONSIDER A PART-TIME NIGHT JANITORIAL POSITION AT \$6.50 AN HOUR.
