COMMISSIONERS EXECUTIVE MEETING 7-14-97 THE COMMISSIONERS MET IN AN EXECUTIVE MEETING AT 9:00 A.M. ON JULY 14, 1997.

IN ATTENDANCE WERE COMMISSIONERS WALT WOOD AND DICK PUCKETT, AUDITOR JUDY CARMICHAEL, AND MAINTENANCE STAFF TERRY PARSON, BOB DROOK AND ROGER NEALIS.

THE MEETING WAS HELD REGARDING THE RESIGNATION OF MAINTENANCE SUPERVISOR, CHARLIE FISHER.

THE COMMISSIONERS ASKED IF TERRY PARSON WOULD CONSIDER MOVING UP TO THE SUPERVISOR POSITION. TERRY STATED THAT HE WAS INTERESTED IN THE POSITION, ADDING THAT HE HAD FILLED CHARLIE'S POSITION FOR VACATIONS AND SICK DAYS ETC. AND HAD GOTTEN ALONG FINE.

WALT WOOD STRESSED THAT THE COMMISSIONERS ARE SERIOUS ABOUT MAKING THE COUNTY BUILDINGS SHINE, AND "STAND TALL".

DICK PUCKETT REQUESTED THAT THE SIGNS IN THE COMPLEX PARKING LOT BE TAKEN CARE OF. HE ADDED THAT HE HOPED TERRY WOULD "TAKE HOLD" AND SEE THE THINGS THAT NEEDED TO BE DONE SO THAT THE COMMISSIONERS DIDN'T HAVE TO POINT THINGS OUT.

WALT WOOD SUGGESTED THAT ROGER NEALIS BE MOVED UP TO DAYS IN THE MAINTENANCE POSITION. HE ASKED IF TERRY WOULD NEED A REPLACEMENT FOR ROGER.

TERRY STATED THAT HE WOULD LIKE TO HAVE ANOTHER NIGHT PERSON ON THE JANITORIAL STAFF. HE STATED THAT CURRENTLY CHARLIE JOHNSON IS OFF ON WORKMAN'S COMP AND THAT THE OTHER STAFF HAS BEEN COVERING THAT POSITION IN THE JAIL. THE COMMISSIONERS SUGGESTED USING PART-TIME HELP AT \$6.50 AN HOUR.

WALT ASKED IT INMATES COULD BE USED TO HELP WITH THE COURT HOUSE LAWN.

TERRY SAID THAT HE WOULD CHECK WITH CAPTAIN BACK TO SEE HOW MUCH INMATES COULD BE USED.

DICK PUCKETT TOLD TERRY THAT HE WOULD BE PUT IN THE SUPERVISOR POSITION FOR A 30 DAY INTERIM TRIAL PERIOD AND AT THE END OF THAT TIME, IF BOTH THE COMMISSIONERS AND HE WERE IN AGREEMENT, THE POSITION AND SALARY WOULD BE HIS. DICK ALSO TOLD TERRY HE WOULD LIKE FOR HIM TO REPORT AT THE MONDAY MORNING COMMISSIONERS MEETINGS.

TERRY SUGGESTED THAT HE FEELS THE DEPARTMENT IS LACKING IN ALOT OF EQUIPMENT. HE ALSO ASKED IF THERE WAS SOMETHING THAT HE FELT THE DEPARTMENT NOT CAPABLE OF DOING, IF HE COULD ASK FOR OUTSIDE HELP. THE COMMISSIONERS ANSWERED THAT HE SHOULD COME TO THEM.

THE MEETING RECESSED AT 9:20 A.M.

OTHER BUSINESS INCLUDED;

A VISIT FROM MARK FLORENCE OF THE SHERIFF'S DEPARTMENT. HE REQUESTED THE COMMISSIONERS TO DIRECT AREA PLAN TO CO-OPERATE WITH THE ELECTION BOARD AND VOTERS REGISTRATION BY GIVING NEW ADDRESSES, NEW SUBDIVISION AND UPDATED MAPS. THE COMMISSIONERS INSTRUCTED THE AUDITOR TO SEND A LETTER DIRECTING AREA PLAN TO DO SO.

THE 99 YEAR LEASE BETWEEN THE COUNTY AND THE HUMANE SOCIETY WAS DISCUSSED.
