THE COMMISSIONERS MET IN THE CITY COUNCIL CONFERENCE ROOM IN THE MARION MUNICIPAL BUILDING, 301 S. BRANSON STREET, MARION, INDIANA 46952 ON MARCH 16, 1998 AT 9:00 A.M.

IN ATTENDANCE WERE COMMISSIONERS DICK PUCKETT, DAVID GLICKFIELD AND WALT WOOD, AUDITOR JUDY CARMICHAEL, HIGHWAY SUPERINTENDENT JOHN WEBSTER, TOM PERRY, JACQUE DODYK, COUNCILMAN PAUL BAKER, RANDY McPIKE OF WBAT, AND CATHY KIGHTLINGER OF THE CHRONICLE.

DICK PUCKETT CALLED THE MEETING TO ORDER AT 9:12 A.M.

WALT WOOD MADE A MOTION TO APPROVE THE CURRENT PAYROLL AND THE CURRENT CLAIMS. DAVID GLICKFIELD SECONDED THE MOTION AND THE MOTION CARRIED THREE AYES.

JOHN WEBSTER REPORTED THAT 1 SIDE WAS POURED ON BRIDGE #181 IN MIER, THAT UTILITIES ARE BEING RELOCATED ON 400E, AND THAT THEY HAVE BEEN SANDING AND SALTING DURING BAD WEATHER AND GETTING READY FOR CONSTRUCTION.

JACQUE DODYK PRESENTED INFORMATION ON THINGS NEEDED FROM COUNTY GOVERNMENT TO COMPLETE THE APPLICATION FOR A \$500,000. HOUSING GRANT TO APPLY TO THE THOMAS JEFFERSON APARTMENTS. DAVID GLICKFIELD MADE A MOTION TO APPROVE ORDINANCE #5-1998, AN ORDINANCE PERTAINING TO FAIR HOUSING. WALT WOOD SECONDED THE MOTION AND THE MOTION CARRIED THREE AYES.
