COMMISSIONERS MEETING - MAY 11, 1998

THE COMMISSIONERS MET IN THE CITY COUNCIL CONFERENCE ROOM OF THE MARION MUNICIPAL BUILDING, 301 S. BRANSON STREET, MARION, INDIANA 46953 ON MONDAY, MAY 11, 1998 AT 9:00 A.M.

IN ATTENDANCE WERE COMMISSIONERS DICK PUCKETT, DAVID GLICKFIELD AND WALTER WOOD, COUNTY ATTORNEY BRUCE ELLIOTT, COUNTY AUDITOR JUDY CARMICHAEL, HIGHWAY SUPERINTENDENT JOHN WEBSTER, THE NEW DIRECTOR OF AREA PLAN TANYA FORD AND RANDY McPIKE OF WBAT.

DICK PUCKETT CALLED THE MEETING TO ORDER.

WALT WOOD MADE A MOTION TO APPROVE THE CURRENT CLAIMS AND THE CURRENT PAYROLL. DAVID GLICKFIELD SECONDED THE MOTION AND THE MOTION CARRIED THREE AYES.

WALT WOOD MADE A MOTION TO APPROVE THE MAINTENANCE REPORT FOR THE WEEK OF MAY 4, 1998. DAVID GLICKFIELD SECONDED THE MOTION AND THE MOTION CARRIED THREE AYES.

JOHN WEBSTER REPORTED THAT THE HIGHWAY DEPARTMENT HAD BEEN BUSY THE LAST WEEK HAND SEALING AND MOWING ROAD SIDES.

BOB EIKENBERRY OF TOTH-IRVIN GAVE A PROGRESS REPORT ON THE COMPLEX RENOVATION. HE STATED THAT CONCRETE WAS PRESENTLY BEING POURED ON ADAMS STREET SIDE OF THE COMPLEX, A NEW CREW HAS STARTED REMOVING PANELS ON THE SOUTH SIDE OF JAIL, GRIDS ARE COMPLETED IN THE LOBBIES, THE TILES DROPPED IN THE JEAN TEAM AREA, AND THAT THEY HAD STARTED PAINTING THE SOUTH STAIR TOWER.

COUNTY ATTORNEY BRUCE ELLIOTT GAVE SOME RECOMMENDATIONS ON A SICK LEAVE BANK FOR THE COMMISSIONERS CONSIDERATION.

THE NEW AREA PLAN DIRECTOR, TANYA FORD, WAS INTRODUCED. SHE AND PHYLLIS DYER STATED THAT AREA PLAN HAD NO OBJECTIONS TO A PROPOSED ORDINANCE TO AMEND GRANT COUNTY CODE SECTION 36-7-600. THIS ZONING CHANGE HAS BEEN REQUESTED BY JAMES AND DONNA LAMBERT, 6209 E. 100 SOUTH, MARION.

DAVID GLICKFIELD MADE A MOTION TO APPROVE ORDINANCE \$7-1998, AN ORDINANCE TO AMEND GRANT COUNTY CODE SECTION 36-7-4-600, AN ORDINANCE CHANGING THE ZONING FROM RESIDENTIAL SUBURBAN TO ACCOMODATION BUSINESS FOR THE COMMON ADDRESS OF NORTH SIDE OF 100 S. WEST OF I-69, MARION. DICK PUCKETT SECONDED THE MOTION AND THE MOTION CARRIED. COMMISSIONER WOOD DID NOT VOTE ON THIS ORDINANCE.
