COMMISSIONERS MINUTES MAY 13, 1998

THE GRANT COUNTY COMMISSIONERS MET IN THE CITY MUNICIPAL BUILDING AT 9:30 A.M. PRESENT WERE DICK PUCKETT, WALT WOOD, DAVID GLICKFIELD, SECRETARY DAWN HARNESS, DIRECTOR OF COMMUNITY CORRECTIONS, CINDY VIRONET, GARY DALTON, BOB TIPPEY OF NX COMMUNICATIONS, AND CHRIS CUNNINGHAM.

CINDY VIRONET PRESENTED TO THE COMMISSIONERS A PROGRAM TO HELP REDUCE TRUANCY BY USING THE INTERNET. BY PUTTING THE CORRECTION FACILITY AND ALL THE SCHOOLS IN GRANT COUNTY ON THE INTERNET, TRUANT AND PROBLEM STUDENTS WOULD AUTOMATICALLY BE KNOWN BY THE PROBATION OFFICE. SHE STATED THAT BY TAKING OUT 4 PHONE LINES PRESENTLY IN THE PROBATION OFFICE THEY WOULD SAVE ALMOST ENOUGH MONEY TO PAY FOR THE INTERNET ACCESS FEES OF \$300 PER MONTH. SHE ASKS THAT THE COMMISSIONERS MAKE A COMMITMENT TO PAY THIS FEE BEFORE THE FINAL STEPS WERE TAKEN BY NX COMMUNICATIONS. THE COMMISSIONERS GAVE THEIR CONSENT AND MENTIONED THAT THEY WERE CURRENTLY WORKING ON GETTING ALL THE COUNTY OFFICES ON THE INTERNET AND WOULD LIKE TO COORDINATE WITH THEM.

CINDY STATED THAT SHE HAS HIRED TWO NEW EMPLOYEES AND WOULD LIKE PERMISSION TO RENT MORE SPACE AT THE IROQUOIS BUILDING. SHE STATED IT WOULD COST \$96 PER MONTH. THE COMMISSIONERS AGREED TO ALLOW NEW SPACE TO BE RENTED.

CHRIS CUNNINGHAM ASKED THE COMMISSIONERS TO RE-APPOINT PAUL KUZORA, TIM ECKERLE, AND JANE LOGAN, AND APPOINT DAVID GLICKFIELD TO THEY COMMUNITY CORRECTIONS BOARD. WALT WOOD MOVED TO MAKE THESE APPOINTMENTS. SECONDED BY DICK PUCKETT. MOTION CARRIED 2 AYES. DAVID GLICKFIELD ABSTAINING.

AT THIS TIME THE COMMISSIONERS MEETING WAS RECESSED.
